- A blank cartridge will be fired in the puppy stakes if bird contact is made.
- **Horseback handling allowed all stakes**
- Use of AKC approved tracking collars is permitted but not provided by the club

Parking

All large rigs/horse trailers will be required to park parallel on the gravel drives. **DO NOT** pull across the grass medians.

DIRECTIONS:

FIELD TRIAL GROUNDS are located at the Middlefork Wildlife Area.

Take Exit 206 (Oakwood) off I-74 and go north approximately 8 miles.

Watch for the large sign on your right- **MIDDLEFORK WILDLIFE AREA**. The ranger station and trial site are about 300 yards off that road.

All Horse Owners-

Horses will need to be staked out at the back of the parking area as much as possible. The barn is almost completed and there are some stalls available

Do not ride across the grass areas by the building.

Please clean up after your horses and dogs. We would like to be welcome to come back to these grounds.

Those on gravel areas need to place manure on the concrete pads and scatter hay/straw refuse in the grass adjacent to them.
